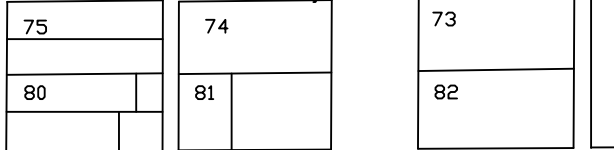
EAST MAIN STREET



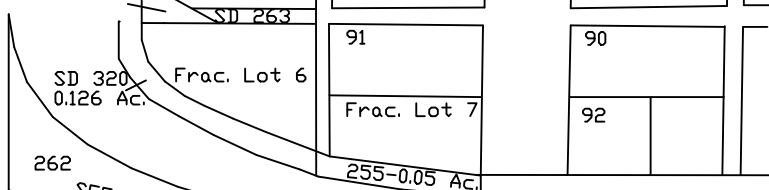
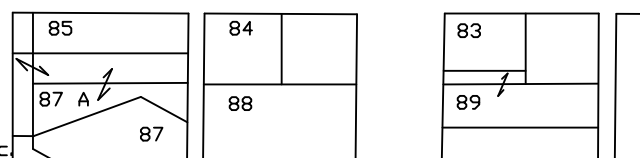
